Preface

This document details price and service changes that will take effect from 31st January 2011. Most of the changes are driven by a legal requirement to charge Value Added Tax (VAT) on some postal services from this date. This document fulfils Royal Mail's obligation under Condition 7 of its Licence to provide three months' notice of changes to licensed and non-licensed services and all other addressed postal services.

Most services will remain VAT exempt beyond January 2011. This includes all services which are price controlled or form part of Royal Mail's universal service obligation. The most popular of these are listed on Royal Mail's website at www.royalmail.com/vat. The prices for these services will not change in January apart from International Signed For (see below).

Section 1 lists the services on which Royal Mail must charge VAT at the prevailing standard rate¹ from 31st January 2011. This is based on the scope of VAT on postal services in the Finance No.2 Bill, which is still before Parliament.

Section 2 details changes to the availability of certain products for purchase on franking machines and online. The products in question become VAT rated from 31st January 2011 and certain payment channels are not equipped to charge VAT in a compliant and customer friendly way.

Section 3 outlines the price impact of VAT on those services listed in Section 1. Prices of services which are not liable to VAT from 31st January 2011 are not included in this section as they are not changing (apart from International Signed For – see below). The VAT rated prices are divided into two categories:

- **Consumer and SME services including franked mail**: all prices are presented inclusive of VAT as customers will see them in Post Office® branches, on franking machines and online. The base (VAT exclusive) price is not changing for any of these services except for International Redirections and International Advice of Delivery (see below).
- Account services for business customers: None of these base (VAT exclusive) prices are changing on 31st January 2011 but VAT will be added at the standard rate. International Contract services are not detailed in this document because this portfolio is currently being redesigned and any changes will be announced in December prior to implementation on 31st January 2011. The redesign is needed to reflect the different VAT treatments between EU and non-EU mail countries that need to be captured for billing.

Section 4 details the new prices which Royal Mail will charge for International Signed For, International Advice of Delivery and International Redirections from 31st January 2011.

4 Price Changes

4.1 International Signed For and Advice of Delivery

The prices for International Signed For and Advice of Delivery will be changing from 31st January 2011. The details are in the tables below. Please note that Advice of Delivery will be liable to VAT at the standard rate from 31st January 2011. International Signed For is exempt, except when purchased with Advice of Delivery, whereby the whole price becomes subject to standard rate VAT to EU destinations.
