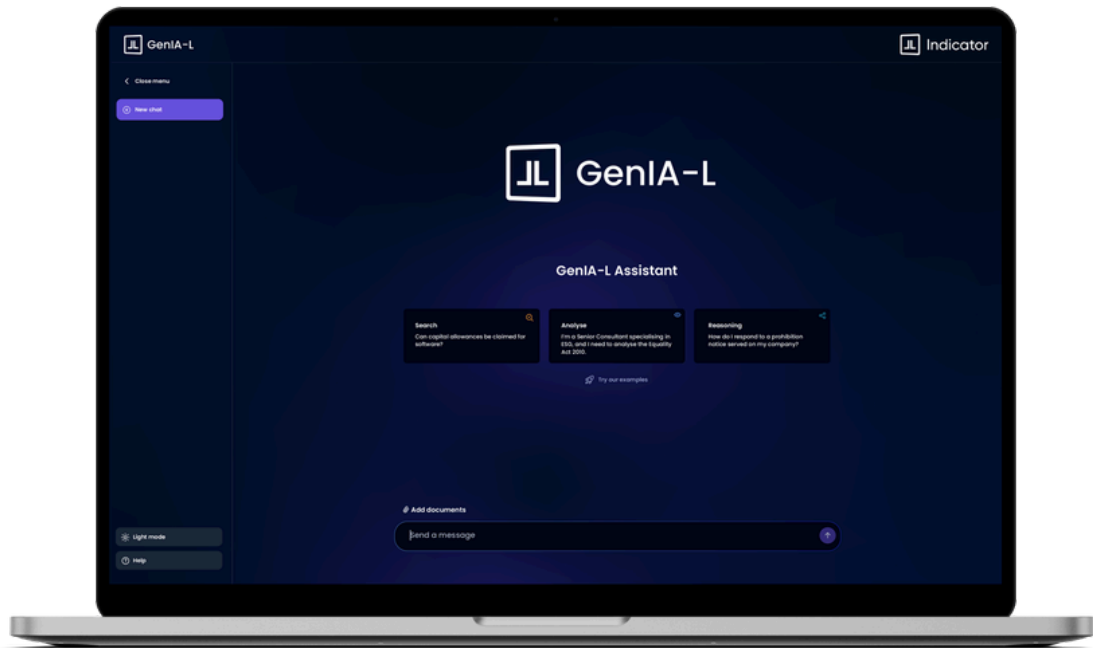

- Best used as part of a professional review process rather than in isolation.
