Big Red Book Limited, established over seventeen years ago, is involved in the design, development, marketing and distribution of accountancy and payroll software for small to medium sized businesses. Big Red Book is owned by Marc O' Dwyer who is also the managing director of the company.

They have 16,000 registered companies using the software throughout Ireland & the UK, running the books for in excess of 35,000 companies. Big Red Book claims to be the largest Irish owned manufacturer of Accounting and Bookkeeping Software. Aimed at the lower end of the small to medium sized business, the company reports owner- managed businesses find Big Red Book an ideal product to use as it gives them accurate financial and management information.

The company's customers include retail, wholesale, pharmacies, auctioneers, solicitors, farmers and general businesses to name but a few.

Big Red Book currently employs 17 staff and its head office is located at Rathdown Hall, Glenageary, Co. Dublin.

Weaknesses

Although the help is comprehensive some of the error messages could be more helpful and the product would benefit from a range of tutorials to get you started.

Value for Money



The modular nature of Big Red Book means that you only have to buy what you need which saves you paying for features that you do not use. There are, however, other comparable software packages that cost less and, of course, several that cost much more than Big Red Book.
